Results and Discussion

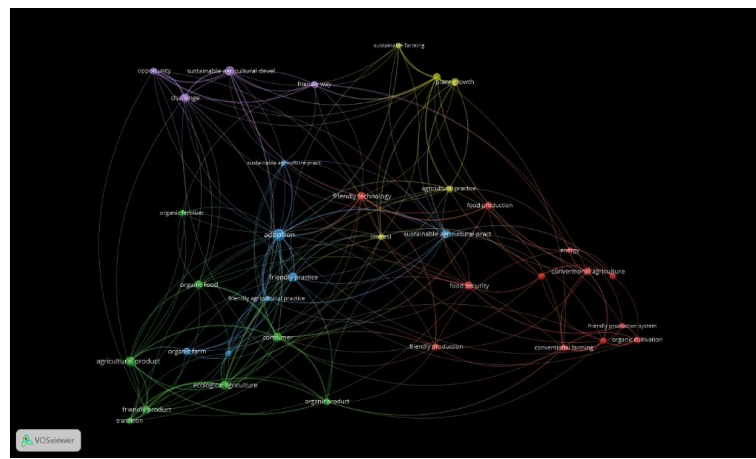


Figure 1: Mapping Results

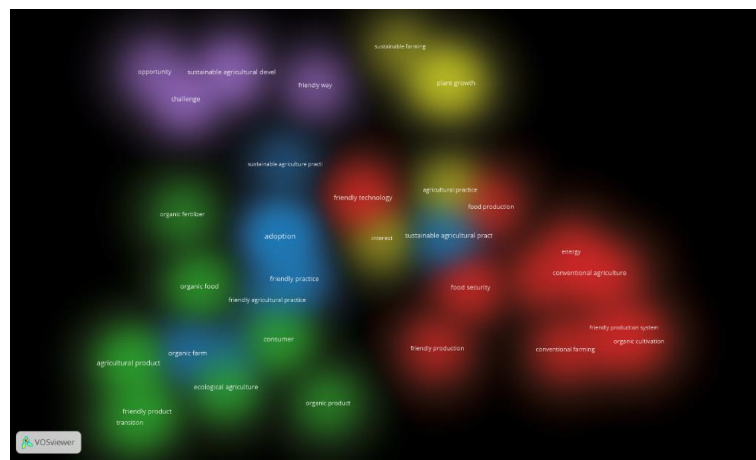


Figure 2. Cluster Results

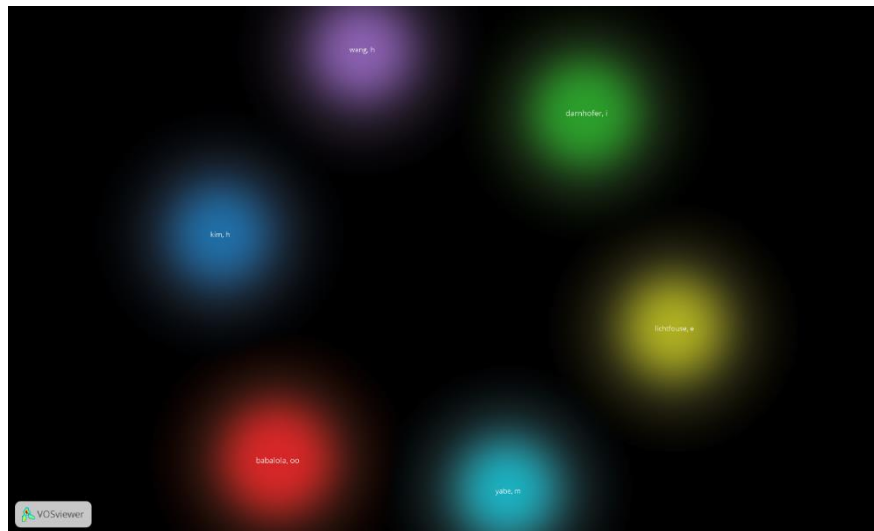


Figure 3. Authors Network
